The value of donated medical supplies and equipment is discounted from its fair market value since CharityVision has no intention of selling the donated items and the medical practitioners have no means to purchase the goods at its fair market value.

While some grants are made to medical practitioners within the United States, these practitioners perform free medical services outside of the United States with the funds, supplies, and equipment provided by Deseret International. As a result, we have reported the total expenditures in column F as well as on line 3 of part IX of Form 990 as representing both amounts sent to organizations within and outside of the United States.
